Several sizes are made available for rental to laboratories for stability testing of specific projects. The required number of model units can be sent upon request and depending on their availability, after receipt of the following:

- Characteristics of the test facilities,
- Test program,
- Design of the projected works to be tested,
- Agreement to issue tests results to the ⁽²⁾ USCOE/SOGREAH Consultants and CLI within 3 months after the end of testing, by post mail or E-mail.

The hirer accepts that the hiring proprietary model units confer obligations on him to ensure that his client is fully aware of that fact. The tests report shall mention the trade name of the armour unit used in the study.

The laboratory hiring the model units shall state in the report that the possible prototype implementation must be backed by sufficient know-how, in order for the tests to remain realistic and meaningful.

CLI cannot under any circumstances be held in any way responsible resulting from the incorrect or misuse of these model units or any consequences arising or resulting from the misuse of them.

2. RENTAL OF MODEL UNITS

2.1. SHIPMENT OF MODEL UNITS

Units are hired on first-come-first-served basis and will be taken as reserved only once CLI receives the order confirmation from the Hirer by E-mail or fax.

The model units will be sent out depending on their location and availability.

The Hirer shall indicate clearly the address to which the model units have to be shipped.
The Hirer shall acknowledge receipt of the model units immediately after the delivery.

2.2. RENTAL PERIOD

The rental period will be calculated from the date of dispatch of the units from to the date of return of the units to

2.3. RETURN OF THE MODEL UNITS

The model units shall be returned immediately after testing.

The date and details of shipping when the model units are returned will immediately be notified by fax or E-mail to CLI.

Clearance through customs :

A. Return of model units rented out of the European Union

In order to be able to clear the shipment upon return back to France, an **ATA CARNET** will accompany the model units, this book includes different custom official documents. The Hirer must ensure that the ATA CARNET will follow the shipment for a return to SOGREAH Laboratory in Grenoble (France).

B. Return of model units rented from WES – Vicksburg (USA)

In case of CORE-LOC™ units from Vicksburg, USA, the following words and statements shall be clearly indicated on the air-bill and shipping documents:

- The goods should be labeled "American Goods Returned" or AGR
- The shipping should be "Deliver Duty Paid"
- Shipment should be IN BOUND TO JACKSON, MS, USA.

3. FINANCIAL CONDITIONS

3.1. HIRE OF MODEL UNITS

The hire rate of CORE-LOC™ or ACCROPODE™ or ECOPODE™ or ACCROPODE™II model units for hydraulic testing is:

- Two (2.00) Euros per kilogram of model units, per week.
- The hire period is indicated in § 2.2
- The shipping costs are born by CLI.

The following costs will be borne by the Hirer:

- The return shipping costs and any local import taxes or duties payable.
- Packing of returned model units:

Before returning the units, the laboratory shall make sure that each model unit is carefully arranged in the box in which it has been delivered. Should the units be returned mixed up, and/or in disorder, the time spent to sort them out and rearrange them, will be invoiced to the Hirer, on the next rental.

- The replacement of any missing unit will be invoiced at the cost of:
15.00 € (Fifteen Euros) per unit.
- Cancellation:

In the event of cancellation of the physical modelling, for any reason, all expenses related to the shipment of the units will be invoiced to the hirer.

3.2. CLI TECHNICAL ASSISTANCE VISIT ⁽³⁾

For a first use of these model units or/and in case of 3D model tests, a CLI specialist will be sent to the laboratory for initial placement for a price to be determined on a case by case basis.

4. CONDITIONS OF PAYMENT

4.1. HIRE OF MODEL UNITS

Upon the return of the model units, CLI will establish an invoice on return of the model units with payment to be made in Euros by the Hirer within thirty (30) days of receipt of the corresponding invoice.

4.2. CLI TECHNICAL ASSISTANCE VISIT

Following each technical assistance visit to the laboratory, a report written in English language will be prepared and sent to the laboratory.

The visit will be invoiced on submittal of the CLI report.

5. CONFIDENTIALITY

Any information and result received from the Hirer is treated as confidential and will not be divulged to third parties (except CLI, SOGREAH Consultants and USCOE) without the Hirer's authorization.

6. VALIDITY OF THE CONTRACT

These conditions remain valid until the return of the model units to their point of origin.

(1) The CORE-LOC™ model units owned by the US Corps of Engineers Research Laboratory: Waterways Experiment Station (WES), are sent from their store in Vicksburg. The other sizes owned by SOGREAH are sent from Pont de Claix. The model units should be returned to the place they originated from.

(2) Depending on the type of model units used, the Hirer agrees to provide the tests results to CLI and the US Corps Of Engineers (USCOE) or SOGREAH Consultants who own the model units.

(3) CLI recommend a visit from one of its experienced specialists to provide technical assistance during the tests and in particular for the placement of the model units.
